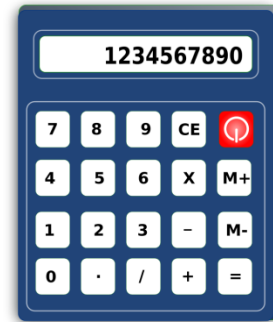

2017 Income Tax Clinics (for 2016 taxes)

Eligibility Guidelines

1. Available to residents of the Nepean, Rideau and Osgoode Communities

2. Total Family Income:

Taxpayer Status	Family Income
Single person	up to \$30,000
Couple	up to \$40,000
One adult with one child	up to \$35,000
Each additional dependant	\$2,500
Interest income	less than \$1,000.

3. Individuals cannot participate in a clinic if any of the following apply:

- You did not live in Ontario on December 2016
- Income over the above-noted income thresholds
- Interest income over \$1,000.00
- Capital gains
- Rental income
- Self-employment earnings
- Employment expenses
- Deceased persons (although this may be waved in some situations)
- Bankrupt individuals (unless the person has received a discharge notice)
- Businesses, corporations, or trusts

Documents Clients need to bring to Income Tax Clinic

- Last year's (2015) tax return & notice assessment from CRA
- SIN or Individual Tax Number (ITN) if you do not have a SIN
- Income Information slips as appropriate to your situation;
 - T4, T4A(OAS), T4A(CPP), T4P,
 - T4RSP, TRRIF,
 - T4E (EI benefits),
 - T5007 (WSB/OW/ODSP),
 - T5008,
 - Child Benefits,
 - T3, T5, Bank Statements (for any RSP, GIC), and any other interest received
 - Foreign Income,
 - Spousal and/or Child Support Receipts,
 - Bursaries or Scholarships.
- Dependents' information, name(s) and date(s) of birth
- T2202 (Education slips)
- Rent or property tax receipts
- Daycare and child activity expenses receipts
- Medical expenses, including health plan premiums
- Disability forms, caregiver receipts
- RRSP receipts, union or membership dues paid
- Moving expenses
- Charitable donation receipts, bus passes
- Spousal information
